*The 3/28/11 newsletter reports that the senate version of the patent reform bill contains a provision for post-grant review of the validity of “covered business-method patents.”

*A 3/22/11 message reports on a CAFC case, *Move, Inc. v. Real Estate Alliance, Ltd*, which held that a patentee is entitled to the full scope of claim language unless the inventor disavowed a particular embodiment.

*The 3/1/11 blog discusses the Patent Reform Act of 2011, which is renamed, the “America Invents Act of 2011.” Significant provisions of the bill include eliminating first-to-invent rights and pre-filing grace periods except for inventor-derived disclosures and post-inventor disclosure disclosures.

*The 3/3/11 blog reports that the Northern District of Ohio found the false marking statute unconstitutional under the “take care” clause.

* The 3/13/11 blog discusses *Microsoft v. i4i*, pending before the U.S. Supreme Court regarding the standard of proof to invalidate a patent based on prior art not considered by the patent office.
